ORDER

As per the Government Order 1st cited, Medical Allowance of Pensioners/Family Pensioners were enhanced @ Rs. 100 (Rupees one hundred only) p.m. w.e.f. 1-3-2006 irrespective of their age. Accountant General, vide reference 5th cited, has requested Government to clarify whether the enhanced Medical Allowance is admissible to part-time contingent pensioners/family pensioners and pro-rata pensioners/family pensioners who were sanctioned Medical Allowance @ Rs. 50 (rupees fifty only) p.m. vide Government Order second and third cited above.

2. Government, after examining the proposal in detail, are pleased to order that enhanced medical allowance @ Rs. 100 (Rupees one hundred only) p.m. will be admissible to part-time contingent pensioners/family pensioners and pro-rata pensioners/family pensioners as well w.e.f. 1-3-2006 irrespective of their age. In the case of Pro-rata pensioners who get absorbed into other institutions, medical allowance will be granted only after final quittance from the absorbed organization.

3. Since pro-rata pensioners are already getting medical allowance vide Government Order 3rd cited, the words "Pro-rata pensioner" appearing in para 4 of Government Order 4th cited stands deleted.
