**ORDER**

In the G.O read (1) above, orders have been issued to amend Rule 86 A Part I Kerala Service Rules to the effect that all officers who have completed 3 years continuous service are eligible to get their Earned Leave for the first year of service recast at the rate of 1/11 of the period spent on duty as in the case of permanent employees. Subsequently Government have clarified in Circular 2<sup>nd</sup> read that the retired employees are also eligible for the benefit of the modified rule.

Since the Government Order read 1<sup>st</sup> above has effect from the date of order, ie, from 27.2.07 only, the benefit of recast of earned leave in respect of pensioners will be restricted to those who retired on or after 27.2.07. It is also clarified that in the case of those pensioners who retired prior to 27.2.07 and enjoyed the benefit of recast of earned leave in pursuance of Circular dated 16.6.07 erroneously, the benefit will not be recovered.

In view of the above, Circular No. 48/07/Fin dated 16.6.07 shall stand cancelled with effect from 16.6.07 itself.
