Sub:- Family pension for life to disabled sons/ daughters of Government Servants/  
pensioners - Issuance of Medical Certificate - Instructions - regarding.

The Accountant General in his letter read above has brought to the notice of the Government that the Medical Board in various districts are reluctant to issue Medical Certificate in the prescribed format. Rule 90(7) Part III KSRs provides the benefit of family pension to the sons/ daughters of Government Servant, who are suffering from any disorder or disability of mind or physically crippled or disabled so as to render them unable to earn a living subject to certain conditions. As per Government Order read as 2<sup>nd</sup> above, the mental or physical disability of the son/ daughter of the Government Servant will be certified by a Medical Board. Vide Government Order 3<sup>rd</sup> cited, Government have prescribed a format for the Medical Certificate to be issued by the Medical Board. Accordingly, all Heads of Departments in the State are directed to comply strictly with the directions in the Government Orders cited while obtaining Medical Certificate for determining the eligibility for family pension to the Mentally /physically challenged children of the Government employee.
