Sub :- Revision of pension/family pension in respect of those coming under UGC/AICTE/Medical Education Scheme - arrears on DCRG and commuted value of pension on account of revision - clarifications issued.

1. As per the GO cited 2<sup>nd</sup> above, Government have sanctioned arrears of pension and family pension in respect of those coming under UGC/AICTE/MES consequent on revision with effect from 01.07.2009.

2. As per the circular cited above it has been clarified that only pre 01.01.2006 pensioners are eligible for revised pension arrears with effect from 01.07.2009. The Circular further clarifies that in the case of those who retired/expired on or after 01.07.2009 and before 01.03.2010, their revised pension is commutable.

3. Now the Principal Accountant General (A&E) sought some clarifications in this regard. Government have examined the matter in detail and are pleased to clarify that the post 01.01.2006 pensioners are also eligible for arrears w.e.f. 01.07.2009.
