The time limit for crediting arrears of Dearness Allowance to the Provident Fund Account of the employees sanctioned as per Government order read as 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup>, 12<sup>th</sup>, 13<sup>th</sup>, 14<sup>th</sup> and 15<sup>th</sup> papers above were extended vide G.O. read as 16<sup>th</sup> paper above and the extended time limit expired on 31<sup>st</sup> March 2014. The arrears of DA sanctioned as per Government order read as 17<sup>th</sup> paper above can be drawn and credited to the PF account of the employee along with the salary bill up to July 2014.

Several requests are being received from various Heads of Institutions and individuals seeking extension of time for crediting the arrears of DA to the Provident Fund Account for the period from 01.01.2005 onwards.

Government have examined the requests and are pleased to order that the time limit for crediting the arrears of DA sanctioned from 01.01.2005, 01.07.2005, 01.01.2006, 01.07.2006, 01.01.2007, 01.07.2007, 01.01.2008, 01.07.2008, 01.01.2009, 01.07.2009, 01.01.2010, 01.07.2010, 01.01.2011, 01.07.2011, 01.01.2012, 01.07.2012 , 01.01.2013 and 01.07.2013 to the Provident Fund Account of employees will be extended up to 31<sup>st</sup> December 2014. The Dearness Allowance arrears can be claimed in the salary bill up to 31<sup>st</sup> December 2014 and credited to Provident Fund Account without fail.

All controlling officers will adhere to the time schedule invariably.


