**ORDER**

In the report of the 13<sup>th</sup> Finance Commission (2010-2015), it has been proposed to set up a pensioner data base which enables aggregation of data of pensioners in the state. In the present pension disbursement scenario, the data of pensioners are scattered around in various treasuries and Banks across the State. This makes it difficult to monitor the expenditure towards pension, accurate assessment of the number of pensioners at any point of time, speedy disposal of grievances of pensioners etc. In order to implement the national policy of bringing transparency in pension distribution and to achieve the vision of the State Government to simplify the pension disbursement architecture, it has been decided to develop an integral Pensioners' Data Base and Portal. To facilitate this, Finance (IT-SF) Department has submitted a Detailed Project Report on a centralized data base of information of all service pensioners in the state.

2. Government after examining the matter in detail, are pleased to accord sanction in principle to develop a central repository containing information of all kind of service pensioners in the State known as Pensioner Information System(**PRISM**) with Pensioners' Portal.

3. Finance (IT-SF) department will develop and maintain the work of the 'PRISM' application. The expenditure in this regard will be debited under the H/A '2075-00-800-99-Setting up a Data Base for Government Employees and Pensioners - 13<sup>th</sup> Finance Commission Recommendation (NP-V)'.
