1.In the Government Order read 2<sup>nd</sup> above, Government have modified the Government order referred 1<sup>st</sup> above in respect of the revising the pension/family pension and those coming under UGC/MES/AICTE Schemes as suggested by the Accountant General vide letter referred 3<sup>rd</sup> above.

The Accountant General vide letter referred 4<sup>th</sup> above has pointed out that G.O referred 2<sup>nd</sup> above envisages protection of drop in emoluments of pensioners who retired prior to the date 01.01.2006 only and also suggested that Government Orders are necessary for protecting drop in

emoluments of post 01.01.2006 employees in which it may be clearly stated in the orders whether drop in pension with effect from 01.07.2009 to 31.12.2011 or drop up to the date of issuance of the proposed orders is to be protected as personal allowance.

2. Government after examining the matter in detail are pleased to accord the sanction for the protection of drop in emolument in case of post 01/01/06 pensioners, those who have not availed leave which does not qualify for pension during the period of Average Emoluments, as personal allowance from 01/07/2009 to 31/12/2011.
