**ORDER**

As per Government Order read 2<sup>nd</sup> above , Government have issued clarification to Government Order referred 1<sup>st</sup> above regarding revision of pension in respect of non-UGC teachers retired prior to 01.01.1986 . The Accountant General Vide letter read 3<sup>rd</sup> above has suggested certain modifications.

2.Government after examining the matter are pleased to issue the following modifications to the Government Order read 2<sup>nd</sup> above.

Sl.No.	Existing provision	Modified Provision
1	Para 4(b)-Family pension of those who retired/expired while in service prior to 01.01.1986 shall be 30% of the minimum of the corresponding revised scale of the post as suggested at Schedule I and II together with Academic Grade Pay (AGP) for the post +DR at Central rates, provided he/she has qualifying service of 30 years or more,in case of others with qualifying service of less than 30 years, family pension proportionate to the qualifying service alone will be admissible.	Para 4(b)-Family pension of those who retired/expired while in service prior to 01.01.1986 shall be 30% of the minimum of the corresponding revised scale of the post as suggested at Schedule I and II together with Academic Grade Pay (AGP) for the post +DR at Central rates.

2	The beneficiaries shall apply for revision in the format appended as APPENDIX I.	The beneficiaries are directed to apply for revision in the prescribed format to the Pension Disbursing Officer (Treasury Officer/Bank Manager) concerned'.
