**ORDER**

Government have implemented National Pension System to the All India Service (AIS) Officers recruited to Kerala Cadre on or after 01.01.2004 vide G.O read as 1<sup>st</sup> paper above and the Scheme has been made applicable to State Government employees who are appointed on or after 01.04.2013 vide G.O read as 2<sup>nd</sup> paper above. Detailed orders for realization of backlog contributions in respect of AIS Officers(Kerala Cadre) and State Government employees were issued vide G.O read as 8<sup>th</sup> paper above.Guidelines for the implementation of NPS in PSUs/Autonomous Bodies/Boards/Universities and Local Self Government Institutions (LSGIs) were issued in Government Orders read as 5<sup>th</sup> and 6<sup>th</sup> paper above.As per G.O read as 7<sup>th</sup> paper above, the present procedures followed in the case of State Government employees has been made applicable to NPS covered employees deputed to State Service from PSUs/State Autonomous Bodies/Boards/Universities/Local Self Government Institutions/Central Autonomous Bodies/Central Government/ other State Governments with respect to registration of subscribers, deduction of employee contribution, providing



equal matching employer contribution and contribution/data upload. Now it has been noticed that there is no provision with regard to realization of backlog contributions in respect of aforementioned employees deputed to State service.

2. In the circumstances, Government are please to order that the present modalities/orders pursued in the case of State Government employees shall be applicable to NPS covered employees deputed to State Service from PSUs/State Autonomous Bodies/Boards/Universities/Local Self Government Institutions/Central Autonomous Bodies/Central Government/ other State Governments with respect to realization of backlog contributions subject to the conditions that the head of accounts now being operated in connection with AIS Officers(Kerala Cadre) shall be used in the case of AIS Officers from other Cadres deputed to State service.

3. The G.O.read as 7<sup>th</sup> paper above stands modified to the above extent.
